





- Others There are many examples of Papercut working in EMR environments - just ask your local ASC if they have examples of your EMR integrating with PaperCut MF










Epic integration with PaperCut Epic app

Questions to ask





- What EMR do you use?
- 2. Do you have another integrations such as identity management (Imprivata for example)?
- 3. Are you looking for Find Me printing or just secure print release?
- 4. What does your fleet mix look like:
 - Single function printers do you require hold and release on these devices?

- 5. What is your current RX (prescription printing) workflow?
 - Do you create forms on the fly or use prescription paper?
- 6. Do you have a list of the different workflows out of your EMR?
- 7. Do you have an audit process for (print) data?





Top questions to ask



- 8. Do you have access to configure your EMR to ensure user data flows through to the print queues?
- 9. Who hosts your EMR printing (could be hospital, EMR provider or even 3rd party provider)?
- 10. Who manages your EMR printing (could be hospital, EMR provider or even third party provider)?
- 11. How many sites are involved in the implementation?

- 12. How many print queues do you currently have?
- 13. VDI setup do you have virtual desktops with shared workstations?
- 14. What is your user sync source (AD or Imprivata)?

Healthcare terms

PaperCut MF

EHR – Electronic Health Record

EMR – Electronic Medical Record; often used to describe the application that a record is held in

FHIR – Fast Healthcare Interoperability Resources

HIE – Health Information Exchange

HIPAA – Health Insurance Portability and Accountability Act

HL7 – Health Level 7; refers to a set of international standards for transfer of clinical and administrative data between software applications

PHI - Protected Health Information

RX printing – pharmaceutical or prescription printing

Back end printing – usually meaning printing directly from the EMR application

Front end printing – usually meaning normal office related printing in a healthcare organization
